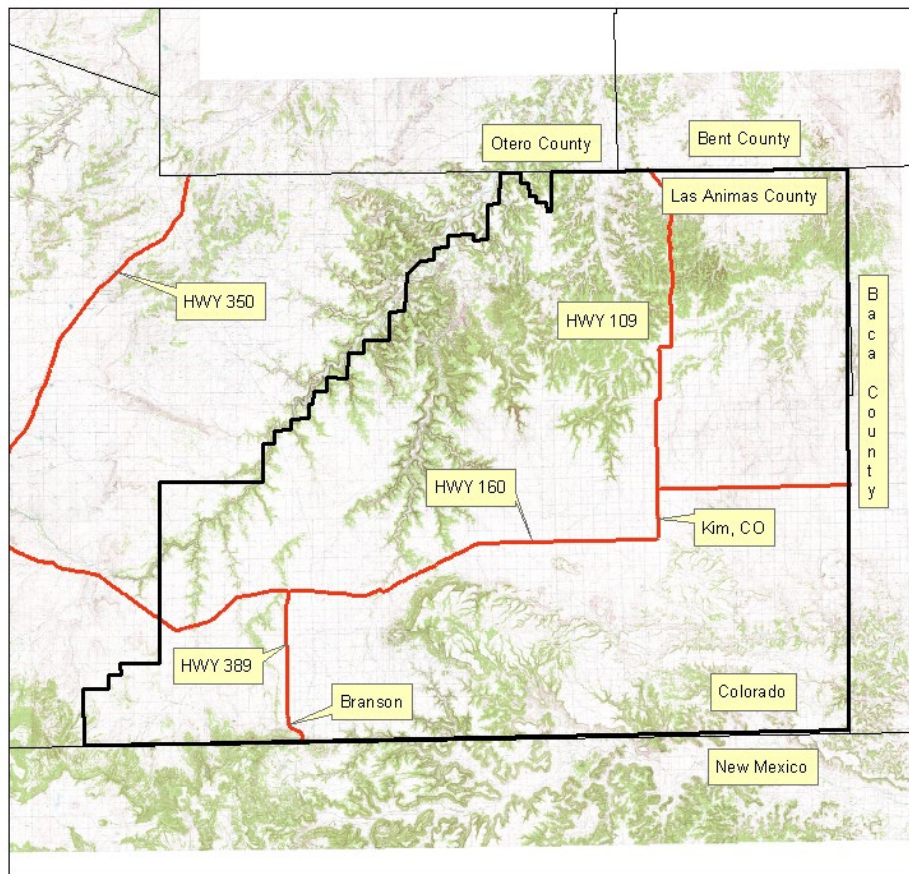

We sell Pronone power pellets (herbicide).



It's about 12 cents a pellet.

Pronone Power Pellet is a herbicide.

Active ingredient Hexazinone

3-cyclohexyl-6-dimethylamino-1-methyl-1,3,5-triazine-2,4 (1H, 3H) dione at 75%

Inert ingredients at 25%

It used to control any woody species such as (Cedar, Mesquite, Yucca, Sagebrush, Huisache, Wild Plum, Oak, Juniper, Tallow, Walking Stick Cactus).

Easy to apply, no special equipment to apply it, no grazing or haying restrictions, remains active even after extended periods of no rainfall. Apply 2-3 pellets per tree over 4 feet tall. Yucca, need to apply 4-6 pellets on a fairly large plant. Apply at the base of the woody specie. Allow up to 6 weeks after a rain, for the herbicide to go into the ground and 1/2-1 inch rain will do that.

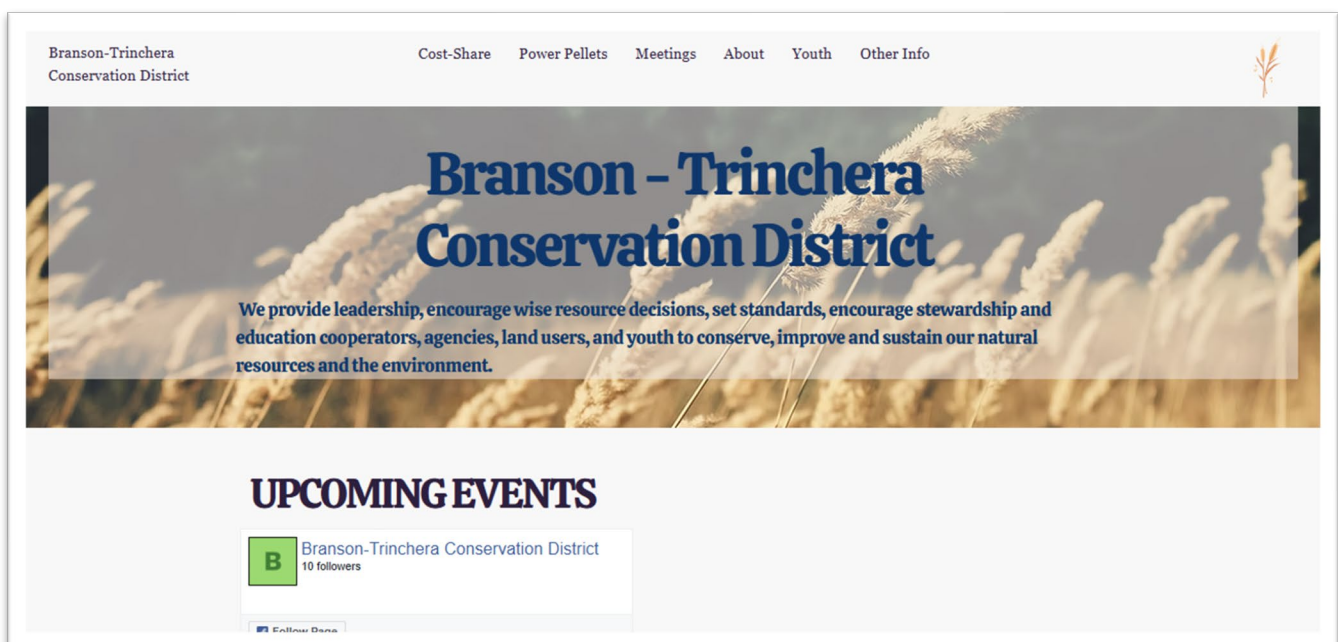

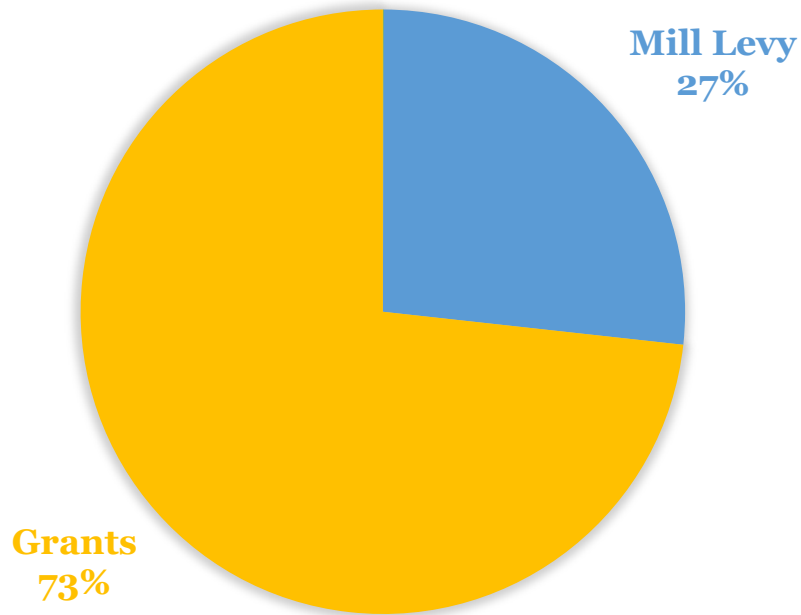
