

Program Rules for 2026 CSCB Matching Grant Cost-Share Program

1. Cost-share is 50/50 meaning: 50% of the project total will be paid by the B-TCD and 50% will be paid by landowner.
2. The maximum cost to be covered will be capped at \$2,500 per landowner.
3. NEW: Landowner must provide at least 2 BEFORE photographs of the project area (via text to our district manager at 407-749-2722 or by email to spprcd@gmail.com)
4. Only private landowners or operators of leased land may apply for this program. If land where practice is installed is leased land the owner of the leased land and the lessor must both sign the application and rules. Valid lease must be provided if requested by the Conservation District.
5. Engineering practices must be planned and installed in accordance with technical standards and specifications provided to the landowner(s) by the Conservation District.
6. The Conservation District is not responsible for any legal disputes regarding property or boundary lines. In the case of questions regarding property or boundary lines, a legal survey is required entirely at the expense of the interested parties and will not be covered by any cost-share.
7. Items of cost for which reimbursement is later claimed are to be supported by documentation of payment made or due to contractors or other workers.

NEW ideas for projects welcome in 2026 including: shade/aqua ball demonstration projects (special ranking bonus for 2026), weed and/or woody species treatments (including cost share with district power pellet sales), solar ideas, de-icing tank demonstration projects, etc. Fencing, water, and similar projects still accepted.

Applications are due by February 27, 2026.

Applicant completes an application in consultation with District or NRCS personnel. All applications go before the Board and will be ranked at the March 18, 2026 meeting. Applicants will be notified by mail of approval and funding level by March 18, 2026. If approved for funding projects may begin starting March 18, 2026, provided that the landowner has consulted with District or NRCS personnel and has the go ahead to start the project.

The applicant will complete the project according to instruction and specifications provided by the Conservation District and will submit invoices to the District office after project completion.

NRCS personnel and/or a District representative will check the project upon completion. The project check out must be requested by landowner and completed on or before close of business on November 20, 2026 to receive cost-share.

Invoices submitted by the applicant, are reimbursed at 50% of the estimated, awarded cost of the project, as stated in your award letter, up to the \$2,500 limit.

All projects must be completed and checked out by close of business on November 20, 2026.

ALL COST OVERRUNS ARE THE RESPONSIBILITY OF THE APPLICANT AND WILL NOT BE REIMBURSED BY THE DISTRICT.

(We) the undersigned, request cost-share assistance for the cost of installing natural resource conservation practices as listed below. It is agreed that:

1. This agreement and payment claim will not be effective until all sections completed and approved by the Conservation District (CD). Form must be submitted w/Reimbursement Request.
2. The authorizing technician must make prior determination (through a site visit) that the requested practices are necessary and feasible on the site propose; they will be appropriately planned and installed; and the costs are reasonable. The landowner must sign in agreement to the request as stated below **before** work begins.
3. Engineering practices should be necessary and practical and evaluated by the Natural Resources Conservation Service (NRCS), their designee, **or be authorized by a professional engineer**.
4. The authorizing technician must inspect completed work & certify satisfactory completion as pre-requisite to cost-share payments.
5. Before receiving any cost-share funds, the landowner(s) must sign the agreement below relating to the installation and maintenance of practices installed.
6. Items for which reimbursement are claimed are to be supported by documentation of payments made or due, or applicable in-kind records, and reviewed by the conservation district Board or assignee prior to cost-share payment.
7. Maximum reimbursement will be limited to the % of the costs as specified below, or the amount obligated by the Conservation District - whichever is the least.
